

## INVITATION TO BID

Sealed proposals will be received until **March 29, 2018 @ 2:00 p.m.** in the Cumberland County Schools' Plant Operations Center, 810 Gillespie Street, at which time they will be publicly opened and read aloud for the **LABOR AND MATERIAL TO SCREEN AND RE-COAT THE GYMNASIUM FLOORS ON THE ATTACHED LIST.**

A **Mandatory Pre-Bid conference** will be held at the Operations Center. Contractors interested in bidding shall meet at **10:00 a.m. on March 15, 2018. The address is 810 Gillespie Street, Fayetteville, NC 28306. The reception desk phone number is 910-678-2609.**

Single prime bids will be accepted in accordance with G.S. 143-128. Complete Bid Documents will be issued **ONLY** at the Pre-bid Conference. Requirements for bidding this project are as follows:

1. Three references from previously satisfied commercial customers.
2. Furnish NC License Number (G.S. Chapter 87 establishes licensing requirements for general, plumbing, heating, electrical, and refrigeration contractors for construction projects costing \$30,000 or more).
3. Insurance - The Contractor shall provide, as required by law, insurance for his employees. The Cumberland County Schools assumes no liability for injuries or accidents related to the Contractual Agreement. The Contractor shall furnish a certificate to the Owner (Cumberland County Schools) as a Proof of Coverage. The Contractor shall maintain and pay the Insurance Coverage, which shall not be less than the following:
  - A. Workman's Compensation statutory
  - Employer's Liability \$1,000,000
  - B. General Liability (per person/per occurrence):
    1. Bodily Personal Injury \$1,000,000/\$2,000,000
    2. Property Damage \$1,000,000/\$2,000,000 Aggregate
  - C. Automobile Liability (per person/per occurrence)
    1. Bodily Injury \$1,000,000
    2. Property Damage \$1,000,000 Aggregate
  - E. Builder's Risk or Installation Floater Contract Amount
  - D. The insurance section should note an additional insured endorsement form as well, listing the Owner and CCS as an additional insured.
4. Recruitment of minority business participation in accordance with G.S. 143-128.
