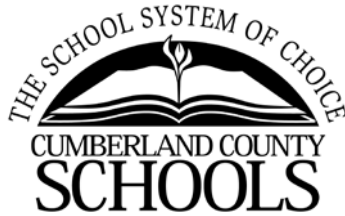

The following changes, additions and clarifications are made to the General Conditions and Specifications for the above referenced project. **Number of pages (6 - including cover)**

1. Bid Form - A revised bid form is being provided as there will be no alternate bid. Contractors are to provide a base bid total and a unit price for materials and labor to install sleepers as needed per each 4' length. The revised bid form is attached.
2. Clarification – Allowances:
 - A. A \$10,000 miscellaneous allowance is to be included in the base bid. This allowance shall cover the as-needed installation of sleepers where existing sleepers are damaged.
 - B. A \$5,000 allowance is to be included in the base bid to cover bleacher movement. The contractor shall use owner's sub-contractor (FaciliServ). FaciliServ will bill the contractor and the funds shall be deducted from this allowance. All coordination for bleacher movement shall be the responsibility of the flooring contractor.
3. Center court logo – Attached are two options the school has chosen for a center court logo. These are representative only of the scope and colors desired for the logo and borders. Final color decision and logo will be made prior to the start of work.
