Sealed proposals will be received until **1:30PM May 29, 2019** in the Cumberland County Schools' Plant Operations Center, 810 Gillespie Street, at which time they will be publicly opened and read aloud for the South View High School Tennis Court Replacement and South View High School Track Repair with Rubberize Resurfacing. These two project will be bid separate.

A **Mandatory Pre-Bid conference** will be held at the school. Contractors interested in bidding shall meet at **10:00 am, May 17, 2019 at 4184 Elk Road, Hope Mills, North Carolina 28348 (910) 425-8181. PLEASE sign in at the office upon arrival.**

Single prime bids will be accepted in accordance with G.S. 143-128. Complete Bid Documents will be issued at the Pre-bid Conference by Blane Hunt, Project Manager, Cumberland County Schools, (678-2557).

Requirements for bidding this project are as follows:

1. Three references from previously satisfied commercial customers.
2. Furnish NC License Number (G.S. Chapter 87 establishes licensing requirements for general, plumbing, heating, electrical, and refrigeration contractors for construction projects costing \$30,000 or more).
3. Insurance - The Contractor shall provide, as required by law, insurance for his employees. The Cumberland County Schools assumes no liability for injuries or accidents related to the Contractual Agreement. The Contractor shall furnish a certificate to the Owner (Cumberland County Schools) as a Proof of Coverage. The Contractor shall maintain and pay the Insurance Coverage, which shall not be less than the following: (See Project Manual for complete details of coverage.)
